## Introduction

Founded in 2014, Tachyus is a leader in operational optimization for the oil and gas industry. Aqueon, our waterflood modeling and optimization platform, powered by our proprietary engine Data Physics, has increased production and reduced costs and GHG emissions for operators worldwide. We also recently extended Aqueon for CO2 EOR optimization and is already being used by major operators in the US.

In early 2022, Tachyus entered the ESG space with Aurion, a fully integrated software platform that helps GHG intensive industries like oil and gas estimate, forecast, optimize and report GHG emissions and intensity. Since then, we have rapidly established ourselves as a leader in this space with over 20 clients in the US, Middle East and Latin America.

## **How we collect and use (process) your personal information**

Tachyus collects personal information about its website visitors and customers. With a few exceptions, this information is generally limited to:

- name
- job title
- employer name
- work address
- work email
- work phone number

We use this information to provide prospects and customers with services.

We do not sell personal information to anyone and only share it with third parties who are facilitating the delivery of our services.

From time to time, Tachyus receives personal information about individuals from third parties. Typically, information collected from third parties will include further details on your employer or industry. We may also collect your personal data from a third party website (e.g. LinkedIn)

## **Use of the Tachyus Website**

As is true of most other websites, Tachyus' website collects certain information automatically and stores it in log files. The information may include internet protocol (IP) addresses, the region or general location where your computer or device is accessing the internet, browser type, operating system and other usage information about the use of Tachyus' website, including a history of the pages you view. We use this information to help us design our site to better suit our users' needs. We may also use your IP address to help diagnose problems with our server and to administer our website, analyze trends, track visitor movements, and gather broad demographic information that assists us in identifying visitor preferences.

Tachyus has a legitimate interest in understanding how members, customers and potential customers use its website. This assists Tachyus with providing more relevant products and services, with communicating value to our sponsors and corporate members, and with providing appropriate staffing to meet member and customer needs.

## **Sharing information with third parties**

The personal information Tachyus collects from you is stored in one or more databases hosted by third parties located in the United States. These third parties do not use or have access to your personal information for any purpose other than cloud storage and retrieval. We do not otherwise reveal your personal data to non-Tachyus persons or businesses for their independent use unless: (1) you request or authorize it; (2) it's in connection with Tachyus-hosted and Tachyus co-sponsored conferences as described above; (3) the information is provided to comply with the law (for example, compelled by law enforcement to comply with a search warrant, subpoena, or court order), enforce an agreement we have with you, or to protect our rights, property or safety, or the rights, property or safety of our employees or others; (4) the information is provided to our agents, vendors or service providers who perform functions on our behalf; (5) to address emergencies or acts of God; or (6) to address disputes, claims, or to persons demonstrating legal authority to act on your behalf. We may also gather aggregated data about our services and website visitors and disclose the results of such aggregated (but not personally identifiable) information to our partners, service providers, advertisers, and/or other third parties for marketing or promotional purposes.

The Tachyus website connects with third party services such as Facebook, LinkedIn, Twitter and others. If you choose to share information from the Tachyus website through these services, you should review the privacy policy of that service. ## **Transferring personal data to the U.S.**

Tachyus has its headquarters in the United States. If it is required or it applies, information we collect about you will be processed in the United States. By using Tachyus' services, you acknowledge that your personal information will be processed in the United States, if it is required or it applies. The United States has not sought nor received a finding of "adequacy" from the European Union under Article 45 of the GDPR. Pursuant to Article 46 of the GDPR, Tachyus is providing for appropriate safeguards by entering binding, standard data protection clauses, enforceable by data subjects in the EEA and the UK. These clauses have been enhanced based on the guidance of the European Data Protection Board and will be updated when the new draft model clauses are approved.

Depending on the circumstance, Tachyus also collects and transfers to the U.S. personal data with consent; to perform a contract with you; or to fulfill a compelling legitimate interest of Tachyus in a manner that does not outweigh your rights and freedoms. Tachyus endeavors to apply suitable safeguards to protect the privacy and security of your personal data and to use it only consistent with your relationship with Tachyus and the practices described in this Privacy Statement. Tachyus also enters into data processing agreements and model clauses with its vendors whenever feasible and appropriate. Since it was founded, Tachyus has received zero government requests for information.

## Data Subject rights

The European Union's General Data Protection Regulation (GDPR) and other countries' privacy laws provide certain rights for data subjects. Data Subject rights under GDPR include the following:

- Rights related to automated decision making including profiling

This Privacy Notice is intended to provide you with information about what personal data Tachyus collects about you and how it is used.

When technically feasible, Tachyus will—at your request—provide your personal data to you.

Reasonable access to your personal data will be provided at no cost. If access cannot be provided within a reasonable time frame, Tachyus will provide you with a date when the information will be provided. If for some reason access is denied, Tachyus will provide an explanation as to why access has been denied.
